## AGREEMENT

I/We, \_\_\_\_\_, am/are requesting the installment payment on my **residential property, business real property, or tangible personal property of the business** for the account number described above that was damaged as a direct result of the disaster declared on June 01, 2016 in BRAZORIA COUNTY, as provided under Sec. 31.032 of the Tex. Property Tax Code and as outlined herein.

**I understand that by signing this agreement I am attesting to and swear to** the fact that I/we have qualifying property and, if a business, is/are a qualified business, as that is defined in Section 31.032.

**I agree to pay this tax office at least one-fourth of the taxes due per installment** and that the initial full payment must be received or postmarked before the February 1<sup>st</sup> delinquency date together with this Agreement.

**I agree to remit the payments timely and in the amount noted.** I understand that I **cannot** pay less than the amount due for each installment above. Payments remitted timely will not accrue penalty and interest charges.

**I understand that failure to make a payment before its applicable due date will cause the unpaid installment amount to become delinquent and to incur a penalty of six (6) percent plus one (1) percent interest for every month the payment is late as provided by Section 33.01(c) of the Texas Property Tax Code**, together with any additional collection cost penalty that is or may become due under Sections 33.07 or 33.08 of the Texas Property Tax Code.

**I understand that the Tax Office will not send payment reminder notices** and that it is my responsibility to make payments for the correct amount by the due dates stated.

**I understand that any homestead property taxes paid in 2017 cannot be claimed on 2016 income tax.**

**I/We hereby affirm** that our qualifying property as described above was damaged during 2016 Brazos River Flood Event in Brazoria County.
