ANNUAL FIRE INSPECTION APPLICATION

This form is to be used for the annual fire inspections for fire and life safety compliance of existing buildings, structures and promises. A separate OPERATIONAL FIRE PERMIT APPLICATION may be required to be submitted to the Brazoria County Fire Marshal's Office accompanying this form for Hazardous Operations and Processes.

Notice: At this time, the 2012 International Fire Code as published by the International Code Council and subsequently adopted by the Brazoria County Commissioners' Court is established as the Fire Code for the unincorporated areas of Brazoria County. Fire and life safety compliance inspections are conducted in accordance with the adopted code Fire Code at the time of building, structure or premise Certificate of Compliance was issued. If in the opinion of the Brazoria County Fire Marshal, as authorized by the Brazoria County Commissioners Court through the Fire Code and law, that a building, structure or premise including occupancy, storage, process and/or lack of fire protection system poses a distinct threat to life and property, the 2012 International Fire Code may be used.

A separate ANNUAL FIRE INSEPCITON PERMIT APPLICATION shall be completed for each separate building, structure and promise.
