CONSIGNMENT BATTERIES

Consignment Batteries are the property of the Vendor. The County does not pay for consignment batteries until a battery is used.

The batteries have been stocked for sale on consignment at the locations listed below as a convenience to the County. Continental Batteries will check the stock twice a month or as needed per the depletion of batteries. Departments participating in the consignment should forward a copy of the initial consignment delivery ticket to Purchasing. Please note that the actual invoice will go to the Auditing Department, purchasing only needs a copy of the delivery ticket.

Departments participating in the consignment must prepare a requisition to Continental Batteries to deplete the consignment inventory **the same day they use the battery**. Purchasing will issue a Purchase Order from the Department's requisition to Continental Batteries and will indicated on the order that it is for depletion purposes only. Continental will invoice the department referencing the Purchase Order number received from Purchasing.

Departments should use the item ID assigned to the battery when entering the requisition (PLEASE SEE ATTACHED CONTRACT SHEET). The State Fee for removal of old batteries is included in the purchase price of each battery that is set up in PeopleSoft.

If more than one person accesses the consignment stock, the department may want to label the batteries with the County ID # to ensure proper usage and depletion. Please be sure that everyone knows that the batteries do not belong to the County. When a battery is removed from stock it must be paid for via a requisition (preferably issued on the same day the battery is removed).

CONTINENTAL BATTERY CORE POLICY

Continental Battery core return policy states that for every battery sold and "exchange" core is required. Continental Battery is required to return all cores to their manufacturer. If a core is not present for return, Continental Battery will charge a \$10.00 fee. If the core becomes available at a later date, the County will be credited back the \$10.00 fee. Core credits of \$10.00 will be issued only up to and not to exceed the number of cores charged to the County.

Please note: Any discrepancies in the stock quantities will be stocking department's responsibility. Further, the department may be required to pay any costs associated to stocking shortages.

Departments should address any Vendor / Contract concerns or complaints in writing via email or interoffice mail to Natasha D.N. Stulberg in the Purchasing Department.

STOCK-OUT DUE TO A DEPARTMENTS FAILURE TO FOLLOW THIS PROCEDURE SHALL NOT BE CONSIDERED A VENDOR ERROR.

By following the procedure indicated above, Continental Battery will be able to restock batteries in sufficient time to prevent stock-outs. Departments should not go to locations other than their own to pick up batteries. If a battery that is not stocked is needed, please see the procedure below for the purchase of non-consignment stock batteries.

Purchase of Non-Consignment Stock Batteries: In the event a battery is needed that is not a consignment battery, please complete a requisition to Continental Batteries listing the battery that is needed. A list of contract batteries is attached and may also be found on the Current Contracts page of the Purchasing website <http://www.brazoria-county.com/purch/contracts.htm> . Departments should use the item ID assigned to the battery when entering the requisition (PLEASE SEE ATTACHED CONTRACT SHEET). The State Fee for removal of old batteries is included in the purchase price of each battery that is set up in PeopleSoft. Once the requisition has been turned into a PO, Continental Batteries will deliver the battery to the specified location within 24 hours.

Emergency Purchases: In the event of an emergency, please contact the Purchasing Department to determine the fastest method available to obtain your battery.
