Jason Filipp—Foreman

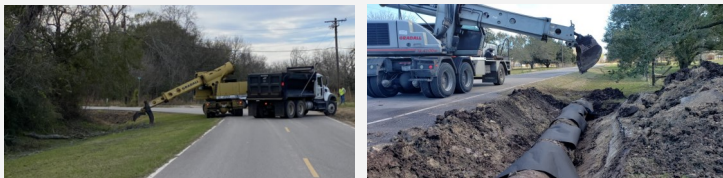
