Public hearings will be held on Wednesday, July 14, 2021 at 5:30 pm and Wednesday, July 21, 2021 at 9:00 am at the Brazoria County East Annex located at 1524 E. Mulberry, Angleton, Texas. The purpose of these hearings will be to receive citizen comments and input regarding the PY 2021 Action Plan. The County anticipates it will receive funding from the U. S. Department of Housing and Urban Development in the amount of \$1,716,085 under the CDBG Program, \$517,255 under the HOME Program and \$154,660 under the ESG Program during Program Year 2021. In addition, Brazoria County has been allocated a one-time funding of \$1,874,707 under HOME-ARP. Please view the attached entire breakdown of project descriptions and amounts.
