

## Texas Police Trainers LLC TCIC/TLETS Training (#4800, #4801 & #4802)



The Texas Law Enforcement Telecommunications System, TLETS, consists of a distributed software application and secure network services. TLETS is provided to over 100,000 Criminal Justice employees, through over 8,800 directly defined workstations and 40,000 devices defined to city and county systems that interface with TLETS. DPS strives to make TLETS available 24x7x365. The core component of TLETS is a store and forward message brokering system that ensures safe, secure delivery of content being transmitted throughout the system.

TLETS provides intrastate interconnectivity for criminal justice agencies to a variety of local, state, and federal data base systems. Additionally, TLETS' link with Nlets, the International Justice and Public Safety Network, facilitates exchange between criminal justice agencies across the state of Texas to their counterparts in other states. The link with Nlets allows DPS to provide critical information to the national criminal justice community and allows TLETS operators to obtain information from a variety of data base services from other states, Canada, Interpol, and private companies.

TLETS also provides the DPS and local criminal justice agencies with access to the Texas Crime Information Center (TCIC); DPS' Computerized Criminal History System (CCH); DPS' Driver License System (DLS); The Department of Motor Vehicles' Registration Title System (RTS), TexasSure – the Financial Responsibility Verification Program (FRVP) and Texas Parks and Wildlife (TPWD).

TCIC/TLETS Mobile Access Operator Training Course (#4800) (8 hours) - This course is for operators who perform TCIC/NCIC functions at any level lower than full access. Generally, this pertains to inquiry only, including mobile data terminal (MDT) or laptop computer operators. It also covers information about driver licenses and vehicle registration. This course requires the TCIC/TLETS Operation Manual Part 1. Operators must receive this training within the first six months of assignment or employment, regardless of whether these duties are performed on a full-time or part-time basis. Course In order to comply with federal requirements, operators must recertify within two years of certification or most recent recertification date.

<u>TCIC/TLETS Less Than Full Access Operator Training Course (TCOLE #4801 - 16 hours)</u> – This course is for operators who perform TCIC/NCIC functions at any level lower than full access. Generally, this pertains to inquiry only. It also covers navigation of the databases that are connected to the TLETS system such as administrative messages,

driver license, vehicle registration, and instructions regarding proper procedures for broadcasting in the state and nationwide. This course requires the TCIC/TLETS Operation Manual Parts 1 - 2. Operators must receive this training within the first six months of assignment or employment, regardless of whether these duties are performed on a full-time or part-time basis. To comply with federal requirements, operators must recertify within two years of certification or the most recent recertification date.

TCIC/TLETS Full Access Operator Training Course (#4802) (24 hours) - This course is for operators who perform all TCIC/NCIC functions, including inquiry, entry, modification, clearing, canceling, and III functions. It also covers navigation of the databases that are connected to the TLETS system such as administrative messages, driver license, vehicle registration, and instructions regarding proper procedures for broadcasting in the state and nationwide. This course requires the TCIC/TLETS Operation Manual Parts 1 - 3. Operators must receive this training within the first six months of assignment or employment, regardless of whether these duties are performed on a full-time or part-time basis. To comply with federal requirements, operators must recertify within two years of certification or the most recent recertification date.
