### **Description of Non-Conformity:**

The Laboratory decided to voluntarily reduce our scope of accreditation through ANAB for all Toxicology services in March 2022. The Quality Manger archived all Toxicology standard operating procedures (SOPs) and related documents. However, the Laboratory was still performing urine analysis for employment and incidental Sheriff Office departmental purposes. The Crime Laboratory was not and is not currently accredited in urine analysis.

#### **Root Cause Analysis:**

All SOPs and forms involving toxicology services were archived once accreditation was withdrawn in March 2022. Not taking into consideration that urinalysis was still being performed under departmental guidelines, not ANAB guidelines, all documents needed reinstatement to continue this process.

## Level of Non-Conformity Determination and its Impact on Casework:

This incident has no bearing on casework owing to the Laboratory has never been accredited by ANAB in urine analysis.
