## **HOME- ARP Allocation Plan Substantial Amendment**

As a result of the RFA process, the County is proposing to amend its HOME-ARP Allocation Plan- Use of Funds section as follows:

- Supportive Services funding is increased to \$456,887/24%
- Non-Congregate Shelter is increased to \$806,078/43%
- Tenant Based Rental Assistance is added and funded at \$300,000/16%
- Development of Affordable rental is decreased to \$0/0%
- Non-Profit Capacity Building is decreased to \$20,000/1%
- Non-Profit Operating is decreased to \$10,536/0.6%
