Required for New Supervisors

Effective September 1, 2015, the House Bill 3211 brought an amendment to Occupations Code 1701.352(d), mandating newly appointed peace officers or those receiving their first supervisory position to undergo in-service training on supervision. This training should not be conducted earlier than 12 months before the appointment date or later than the first anniversary of the appointment.
