Topics include the use of threat matrix, scouting procedures, mission planning documentation, operational planning for high-risk search warrants and briefing procedures. Primary, alternate, contingency, emergency planning, suggestions on how to modify high risk search warrant planning to other types of tactical missions, and much more will also be discussed. The primary goal of this course is to expose attendees to the intricacies of high risk search warrant, planning, and briefing to allow for mission success. This is NOT a tactics or scouting course. Various tactical and scouting options will be discussed to demonstrate the flexibility of the briefing process.
