1. The location and description of the proposed installation and appurtenances must be shown on the attached drawing.
2. All construction and materials shall be consistent with the approved permit and subject to inspection and field approval by Brazoria County personnel.
3. Brazoria County personnel will size and set the culverts in accordance with the Brazoria County Driveway Policy. Applicant will provide the material required for Brazoria County to set the culverts in accordance with the Brazoria County Driveway Policy.
4. Applicant shall notify Brazoria County Engineering Department at least 48 hours prior to start of construction of driveway within the Right-of-Way.
5. Other permits may be required for further development. Please contact the Brazoria County Engineering Department for regulations pertaining to the subdivision of property; the Floodplain Department for Building and Fill Permits; and the Health Department for information on On-Site Sewage Facility permits prior to planning any additional construction.
6. Applicant shall indemnify, defend, and hold harmless Brazoria County, Texas and its duly appointed officials, agents, and employees against any action based on personal injury or property damages sustained by reason of the exercise of this permit.
7. Any permit issued for the above referenced Driveway/Culvert shall become null and void six months after date of issuance. Brazoria County reserves the right to require a new permit application in the event of a land use change or a change in driveway traffic volume or vehicle types.

**Notes: Concrete surface will require an Inspection prior to concrete pour in order for Permit to be issued. If Inspection is not complete, the County will remove concrete within the Right of Way.**

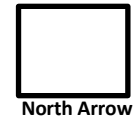
