By allowing a permit holder to operate a vehicle over Brazoria County roads when the vehicle exceeds applicable weight limits, Brazoria County is acting within its police power to not only regulate the usage of those roads but also to allow the permit holder to do that which would otherwise be illegal. As such, Brazoria County's grant of authority to the permit holder under section 623.018 is a license/permit instead of a contract, as those terms are used in Texas law.

This <u>permit</u> is only good for 90 days per Texas Transportation Code § 623.018(b). The bond may be obtained on an annual basis.
